- CTDL + Hope Career Grant update although we have heard that an exception will be made to waive the "one term disbursement rule" for this program, I have not seen anything in writing. Derek has not received response from GSF.
- Health Program clinical hour accommodations any updates to the spreadsheet/document you sent? Also, with regard to CNA, for purposes of the limited lab request and social distancing concerns, can the allowed 24-hr skill requirement in the lab be performed on manikins rather than other students? (Language below suggests no.)
